*Full masked genome sequences for Macaca mulatta (UCSC version rheMac3)*

---

## Description

Full genome sequences for *Macaca mulatta* (Rhesus) as provided by UCSC (rheMac3, Oct. 2010) and stored in Biostrings objects. The sequences are the same as in BSgenome.Mmulatta.UCSC.rheMac3, except that each of them has the 4 following masks on top: (1) the mask of assembly gaps (AGAPS mask), (2) the mask of intra-contig ambiguities (AMB mask), (3) the mask of repeats from Repeat-Masker (RM mask), and (4) the mask of repeats from Tandem Repeats Finder (TRF mask). Only the AGAPS and AMB masks are "active" by default.

The masks in this BSgenome data package were made from the following source data files:

AGAPS masks: gap.txt.gz from <http://hgdownload.soe.ucsc.edu/goldenPath/rheMac2/database/>  
RM and TRF masks: rheMac3.fa.out.gz and rheMac3.trf.bed.gz  
from <http://hgdownload.soe.ucsc.edu/goldenPath/rheMac3/bigZips/>
